As a member of SHARE Multi-Academy Trust, they act as our admission authority. If your address is within Calderdale then please apply via Calderdale Council. If your address is within a different local authority area then you can still apply for a place at Todmorden High School a SHARE Academy via the admissions team for your local authority. If you wish to make an application for your child to transfer to our school from another secondary school or home education, then please contact your local authority admissions team and they will be able to guide you through the process.

The admission criteria for Todmorden High School a SHARE Academy in September 2026 are as follows:

Admission at age 11

Children are admitted without reference to ability or aptitude. The Published Admissions Number (PAN) for the academic year commencing September 2023 is 180 in each year.

Children will be given priority to the school named in their Education, Health and Care (EHC) plan.

Where applications for admission exceed the number of places available, places will be allocated in the following order of priority:

1. Pupils who are in public care (children looked after) or pupils who were previously looked after but ceased to be so because they became adopted or became subject to a child arrangements order or special guardianship order.
2. Children who were previously in state care outside of England and have ceased to be in state care as a result of being adopted.
3. Pupils living within the defined priority (catchment) area who have:
 - A sibling who lives in the same household and is currently at the school.
 - This does not include pupils in their final year.
4. Other pupils living within the defined priority (catchment) area.
5. Those pupils who do not qualify under Categories 1-3 who have a brother or sister (including step/half brothers and sisters) permanently resident in the same household and currently attending the school (excluding pupils in their final year).
6. Children of staff employed by SHARE Multi-Academy Trust. 'Staff' for this purpose are defined as anyone employed by Todmorden High School a SHARE Academy who has held a contract for two or more years at the time of application, or the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.
7. Other children.

Notes

If there is over-subscription within any category, then pupils will be admitted in the order of proximity of the pupil's permanent home to the school.

Distance will be calculated using a straight-line measurement from the pupil's permanent home to the closest designated school gate.

Distance will be calculated using the Local Authority's GIS system (Geographical Information System). To ensure consistency applies, all measurements will be carried out using the Local Authority's GIS system and no other method of measuring distance will be considered.

Each property has a coordinate taken from Ordnance Survey Address-Point data. This is the point which distance measurements will be taken from.

In the event of two or more children living equidistant from the school the decision on which child will be allocated will be made using random allocation.
